As an investor in one or more of the Funds, we would like to notify you that Threadneedle Investment Services Limited, the authorised corporate director (the "ACD") of Threadneedle Investment Funds ICVC ("TIF"), and Threadneedle Management Luxembourg S.A., the management company (the "ManCo") of Threadneedle (Lux) ("T(Lux)"), have decided to cease marketing the UK Funds and the Lux Funds, respectively, to the public in Hong Kong in future and to apply to the SFC for the withdrawal of the authorisation of the Funds.

Why did the ACD and ManCo apply to the SFC for withdrawal of the authorisation of the Funds?

In relation to the UK Funds, the ACD has concluded that as part of its business strategy, it will focus its marketing activities for Hong Kong investors on Luxembourg-domiciled funds rather than UK-domiciled funds. Columbia Threadneedle already markets a range of its Luxembourg-domiciled funds to the public in Hong Kong and this is expected to expand going forward. As a result, the marketing activities relating to the public in Hong Kong for the UK Funds will cease and the SFC authorisation of the UK Funds will be withdrawn, subject to obtaining the SFC's approval.

Concurrently, as part of our ongoing review of our fund offerings in Hong Kong, due to a lack of market demand from Hong Kong investors, the ManCo is of the view that the Lux Funds have limited growth potential and has decided to cease the offer of the Lux Funds. Presently, these funds are already not marketed to the public in Hong Kong. For these reasons, we intend to apply for the withdrawal of the authorisation of the Lux Funds.

When will the withdrawal of authorisation of the Funds take effect?

We will no longer market the Funds to the public in Hong Kong with immediate effect, and the withdrawal of authorisation of the Funds will take effect as of 28 February 2020 (the "Effective Date").

What happens next?

From the Effective Date, the Funds will no longer be regulated by the SFC and will not be available for public distribution in Hong Kong. The product documentation specific to the Funds, including the marketing materials that are currently in the possession of Hong Kong investors, should be retained for personal use only and not for public circulation after the date of this notice. There are no proposals or intended changes to the features and risk profiles of the Funds, including but not limited to the objectives and investment strategies of the Funds. There is also no proposed increase of the level of fees payable by the Funds and/or shareholders, as currently disclosed in the Hong Kong offering documents of TIF and T(Lux), nor proposed changes to the operation of the Funds and, consequently, there is no effect on existing investors as a result of the withdrawal of authorisation.



The ACD and the ManCo shall continue to manage the Funds in accordance with the Funds' respective constitutive documents despite the withdrawal of authorisation. TIF, T(Lux) and the Funds will continue to be subject to the supervision by their respective home regulators, i.e. Financial Conduct Authority in the United Kingdom for TIF and the UK Funds, and the Commission de Surveillance du Secteur Financier in Luxembourg for T(Lux) and the Lux Funds.

We will no longer accept subscriptions or conversions into the Funds from the date of this notice. However, you will continue to be able to keep the holdings you currently have in the Funds. You will also continue to be able to redeem your shares of the UK Funds and Lux Funds. In addition, Shareholders of the UK Funds may exchange your shares for shares of other sub-funds of TIF and Threadneedle Specialist Investment Funds ICVC, and shareholders of the Lux Funds may exchange your shares for shares in other sub-funds of Threadneedle (Lux), respectively, that are authorised by the SFC in Hong Kong¹ free of charge until 20:00 hrs (Hong Kong time) on 27 February 2020.

作為一項或多項各基金的投資者,謹此致函通知閣下,天利投資基金(Threadneedle Investment Funds ICVC)(「天利投資基金」)的受權公司董事Threadneedle Investment Services Limited(「受權公司董事」)及天利(盧森堡)(天利(盧森堡))的管理公司Threadneedle Management Luxembourg S.A.(「管理公司」)已分別決定在日後停止向香港公眾人士進行關於各英國基金及各盧森堡基金的市場推廣,並且向證監會申請撤回各基金的認可。

受權公司董事及管理公司為何向證監會申請撤回各基金的認可?

就各英國基金而言,受權公司董事已得出以下結論:作為其業務策略的一部分,其將專注於以香港投資者為對象、關於在盧森堡註冊基金而非在英國註冊基金的市場推廣活動。天利目前已在向香港公眾人士進行關於其一系列在盧森堡註冊基金的市場推廣,並預期會在日後拓展此類市場推廣。因此,對於香港公眾人士而關於各英國基金的市場推廣活動將告停止,各英國基金的證監會認可亦會被撤回,惟須先取得證監會的批准。

同時,基於我們對在香港提供的基金選擇的持續檢討,由於缺乏來自香港投資者的市場需求,管理公司認為各盧森堡基金的增長潛力有限,並已決定停止發售各盧森堡基金。目前,關於此等基金的市場推廣已不再以香港公眾人士為對象。鑑於前述理由,我們擬申請撤回各盧森堡基金的認可。

各基金的認可撤回將於何時生效?

我們從即日起將不再向香港公眾人士進行關於各基金的市場推廣,而各基金的認可撤回將自2020年2月 28日(「生**效**日期」)起生效。

後續事項

自生效日期起,各基金將不再受證監會規管,並將不可在香港向公眾分銷。各基金的專屬產品文件,包括香港投資者目前管有的市場推廣材料,在本通知書日期後均應僅為個人用途而予以保留且不可作公開傳閱。概無關於各基金的特點及風險狀況(包括但不限於各基金的目標及投資策略)的建議或擬作變動。亦概無建議增加天利投資基金及天利(盧森堡)的香港銷售文件目前所披露的各基金及/或股東應付的費用水平,亦無建議更改各基金的運作,故撤回認可一事不會對現有投資者造成影響。

即使有關認可被撤回,受權公司董事及管理公司仍會繼續按照各基金各自的組成文件管理各基金。天利投資基金、天利(盧森堡)及各基金會繼續受到其各自所在地的監管機構監督,即天利投資基金及各英國基金受英國金融市場行為監管局監督,天利(盧森堡)及各盧森堡基金則受盧森堡金融業監管委員會監督。

自本通知書日期起,我們將不再接受認購或轉換為各基金的要求。然而,閣下將可繼續持有目前在各基金中的持倉。閣下亦將可繼續贖回各英國基金及各盧森堡基金的股份。此外,直至2020年2月27日晚上8時正(香港時間)為止,各英國基金的股東可免費將其股份交換為天利投資基金及天利投資專業



基金的其他子基金(獲香港證監會認可者¹)的股份,各盧森堡基金的股東則可免費將其股份交換為天利(盧森堡)的其他子基金(獲香港證監會認可者¹)的股份。
