Dear Investor,

As a shareholder in one or more of the Funds, we would like to inform you about certain changes made to the Funds.

All capitalised terms not defined herein have the same meaning as in the prospectus of TIF.

These changes will not affect the way the Funds are managed nor change the risk profile of the Funds.

Reduction of Management Fee of UK Smaller Companies Fund

From 1 September 2020, the management fee of Class 1 Shares of UK Smaller Companies Fund has been reduced from 1.5% of the net asset value to 1.4% of the net asset value.

Change of name of the Registrar's delegate

The ACD as registrar of TIF has delegated certain administrative and ancillary services to DST Financial Services Europe Ltd. From 30 March 2020, DST Financial Services Europe Ltd has been renamed as "SS&C Financial Services Europe Ltd".

Updates to the availability of Class 1 Shares

We are updating the description of the availability of Class 1 Shares, which shows the types of investors for whom the Share Class may be available, and updating the disclosure to reflect that the Share Classes are available subject to the discretion of the ACD.
